Due to a large client rebate resulting from fee calculation errors, and the subsequent directive from the Ontario Energy Board, the Town's dividend will be lower than anticipated.

#### 7. Public Question Period

Jessica Deaken, Dayne Deaken and Trevor McAlister addressed Council regarding the condition of the Town's gravel road network. They felt that several sections were not safe to drive on. They advised that the recent road closures resulted in heating fuel truck deliveries being postponed. They asked Council to take steps to fix the roads quickly, acknowledging that external assistance will likely be needed as the number of repairs will be beyond the Town's staff capacity. Council directed staff to start an investigation into options for improvements the roads, including the possibility of external assistance.

#### 7.1. Laren Raan – cannabis stores

Council received the letter and directed the planner to present a response to explain that the Town does not regulate the types of retail businesses that use the commercial space, and that the Town has authorized cannabis stores so if a business believes that operating a retail outlet is financially profitable, they are permitted to do so within the scope of all applicable legislation and regulation.

- 2. Vehicle For Hire By-law
  - Recommendation report to replace our existing by-law with a bylaw operated under a joint agreement with Orangeville will be presented in June. The new by-law will cover licensing, customer fee structure, ride sharing, etc.
- 3. Telecommunications Interoperability project
  - Due to unforeseen circumstances, the Town of Orangeville was not able to apply for the grant funding that was to be used to pay for the interoperability capital projects. As a result, this project has been cancelled.

  - iii. Municipal Employees and budget to look after staff

- iv. Feeling part of the community, both new residents and long-term families
- v. Town support for community building
